## Instructions for NACWA Peak Performance Awards Application - 2015

---

### Eligibility

All treatment facility applicants must be publicly owned by a current NACWA member agency and be in operation for at least one month or more during 2015. Treatment facilities must provide, at minimum, secondary treatment, or advanced primary treatment with a 301(h) waiver. Treatment facilities of all sizes are eligible (i.e., no minimum hydraulic design capacity). Facilities must operate under a Federal or state equivalent NPDES permit, an underground injection control permit, or a state control mechanism that regulates effluent quality and reuse of reclaimed flows.

### 1. Agency Name

Please indicate the name of the agency as it should appear on the award certificate.

### 2. Facility Name

Please indicate the name of the facility as it should appear on the award certificate.

### 3. Facility Address

Please indicate the location address of the facility.

### 4. Contact

Please indicate the person to contact regarding questions on the award application. This person will also receive a confirmation either by email upon receipt of the application, unless otherwise indicated.

### 5. Contact Phone / Email

Please indicate the phone and email information for the person to contact regarding questions on the award application. If an email is not provided, the contact will not receive a confirmation of application receipt.

### 6. Facility Effluent Quality for 2015

Please summarize the facility's effluent results for the requested parameters. For flow, indicate the average daily flow in million gallons per day (MGD) when the facility is in operation. For the remaining parameters, (BOD, CBOD, TSS, ammonia-nitrogen, and phosphorus), please indicate (if available) the average effluent concentration (milligrams per liter) for 2015.

### 7. Permit Number

Please indicate the applicable state or federally-issued permit number for the facility. If the facility does not have a federal or state-equivalent NPDES permit regulating discharge to surface water (i.e. uses deep well injection, infiltration from surface basin, agricultural or landscaping reuse, etc.), please provide the applicable

federal or state permit number that regulates treated effluent flows from the facility.

*Note: Please complete a separate application sheet for each regulated outfall in the applicable permit. Indicate the outfall number at the end of the permit number (e.g. XX34000500-001, XX34000500-002 for outfalls 001 and 002).*

### 8. Design Capacity

Please indicate the average daily design flow in million gallons per day (MGD) for the plant.

### 9. Treatment Level

Please indicate the highest level of treatment attained at this treatment plant for the majority of flows treated. If the facility attains higher removal of pollutants (e.g., nutrients) beyond traditional secondary levels within the existing secondary treatment structures, indicate "advanced secondary treatment." Respond with "tertiary treatment" if the plant has additional physical structures/units (e.g., filters), providing physical, chemical, or additional biological treatment to remove nutrients or other parameters.

### 10. Application For (Award Type)

Circle or highlight the award for which this facility is applying. The available awards include:

- **Platinum Awards:** *Platinum Awards* recognize 100% compliance with permits over a consecutive five-year period. *Platinum Awards* will be given to facilities with a consistent record of full compliance for the calendar years of 2011 through 2015. This application packet contains a list of facilities that, based on NACWA's records, are eligible for a *Platinum Award* if the facility once again attains full compliance for the entire 2015 calendar year. If your agency has a facility that you believe is eligible for a *2015 Platinum Award*, but is not included on the enclosed list, please email or fax a copy of your *Gold Award* certificates from the past four years (2011, 2012, 2013, and 2014) to Mark Hoeke at [mhoeke@dfinet.ch](mailto:mhoeke@dfinet.ch) or fax: 202/318-1472.

Also, *Platinum Award* certificates show the number of consecutive years in full compliance. If your facility has attained full compliance for a longer consecutive time period than shown in the attached list of facilities, and you would like this to be reflected on the 2015 *Platinum Award* certificate, please submit additional award applications for prior years (must be consecutive with time period listed).

- **Gold Awards:** *Gold Awards* recognize 100% compliance with permits for the past calendar year, and are presented to facilities with no permit violations in 2015.
  - **Silver Awards:** *Silver Awards* are presented to facilities with no more than five permit violations in 2015.

### 11. Total Permit Violations

Please indicate the number of permit violations the facility experienced in 2015.

### 12. Total Compliance Points

To determine the number of compliance points, you should determine how many comparisons of analytical result data (either individual sample results, or aggregated averages), have been made with the facility's permit limits. For instance, if the facility effluent is sampled daily for BOD and has daily, weekly, and monthly concentration limits in its permit, the total number of compliance points would be calculated by summing up the number of comparisons made to the permit limits. This would include 365 daily sample results, plus 52 weekly averages, plus 12 monthly averages (365 + 52 + 12 = 429 compliance points). Daily, weekly, and monthly mass limitations for BOD would add another 429 compliance points. Another example would be parameters with solely monthly average limits that are sampled once per year. These would constitute one compliance point each. For each limited parameter that is monitored continuously, please use 365 compliance points.

### What Parameters Should Be Reported?

Include all parameters specified in the facility's NPDES permit, or other applicable federal or state permit that have specific effluent limitations. With the exception of facility flow rates, do not include parameters that have monitoring only requirements. You may change the units reported on the form, if your permit or sampling program uses different units.

Please use the Excel spreadsheet application form where possible, however, if the survey form is not adequate to show all permit requirements and discharge results, it may be modified (e.g., replace BOD with CBOD) or a separate table may be submitted. For example, if the permit has daily, seasonal, or other limits the table should list these and indicate the number of violations. If a separate table is submitted, please ensure that it includes responses to questions 1 to 12.

Please report average daily flow for each month, even if flow is not limited in your permit, however, do not include a flow limit, unless exceedances of the limit are considered violations of the permit.

### Number of Violations

For each parameter limited in your NPDES permit, list the number of permit violations (if any), occurring in the calendar year. If the facility is not regulated under an NPDES permit, please indicate the number of violations (if any) with the applicable federal or state permit that regulates treated effluent from this facility in the calendar year.

### What to Submit

Each application must include a copy of the applicable federal or state-issued NPDES permit requirements (except for those facilities with permits already on file with NACWA as discussed below). You need only submit the portion of the permit directly applicable to your effluent limitations. A copy of a completed Discharge Monitoring Report (DMR) from a typical month that includes permit limitations may be substituted for a copy of the permit requirements.

If the facility is not regulated under an NPDES permit, please include a full copy of the federal or state permit that regulates the treated effluent from this facility, e.g. underground injection permit, state permit or order regulating reuse, etc.

If your facility submitted a copy of permit limits along with a *Peak Performance Award* application in any year between 2005 and 2014, AND the facility's permit limits have not changed, you do not need to include a copy of the facility permit requirements for 2015. NACWA has provided a list of facilities with permit requirements already on file in this application packet.

### How to Submit Your Application

There are several methods to submit your *Peak Performance Award* application. The most preferable method, especially if you are submitting a significant number of pages, or several applications, is by U.S. postal service at the following address:

In this way, NACWA receives your award application in a properly compiled format, and the application forms are most legible.

For those applicants that have relatively standard NPDES permit requirements, we encourage you to visit *Cleanwater Central*<sup>™</sup> ([www.cleanwatercentral.org](http://www.cleanwatercentral.org)) to complete your application online. You must use your agency's *Cleanwater Central* website user id and password to login into *CleanWater Central*. If you do not know your agency's
