1:00-2:30 Ensuring Community Trust, Enhancing Your Agency's Reputation

There are unparalleled pressures today on clean water agency leaders that threaten to undermine the painstaking efforts their agencies have made to become local anchor institutions for their communities. Expectations have been raised to address environmental justice and diversity, equity and inclusion (DE&I) issues, but are these expectations clear and how will we know if they are being met? Similarly, fear about PFAS and emerging contaminants is at an all-time high, whether in drinking water, biosolids, or air emissions. How can the clean water community address these fears through both words and actions while also ensuring regulatory and permit requirements are reasonable? NACWA Board and Committee leaders will provide perspectives from their utilities on these issues and lead discussion on the following sub-topics:

- What challenges are threatening your reputation as a trusted local entity?
- How are you responding differently today versus in the past?
- How are events in places like Jackson, Mississippi, where ratepayers have simply lost trust entirely in their local, state and federal institutions, impacting your community and the water sector as a whole?
- What role, if any, can NACWA play to further enhance local utility trust within their communities or the clean water sector's reputation nationally?

3:00-3:45 Top Challenges for Utilities in the Sunshine State

Leaders from several Florida utilities (NACWA Members and Non-Members) will provide an overview of their top challenges including the aftermath of Hurricane lan, keeping up with rapid growth, climate issues, aging infrastructure, workforce, water reuse and biosolids management. To set up the final discussion of the day, the panel will then explore whether the issues facing Florida utilities are national in scope, requiring national advocacy or mostly local or requiring more targeted, state-based advocacy. Participants will also discuss the role and efficacy of their state-based associations versus the role and efficacy of national associations, including NACWA, as well as what NACWA could do to be more responsive to Florida utility needs.

3:45-5:00 NACWA's Role in State-to-State Advocacy and Collaboration with State Utility Groups

Key policy and legal decisions are increasingly being made by state legislatures, regulatory bodies and courthouses, which have enormous impacts on our utility members in those states and sometimes serve as national precedents. Recent examples include lobbying efforts by the private water sector with state legislatures to better enable the privatization of water systems and action by the

state legislature in Maine to ban biosolids land application due to the presence of PFAS, despite other states pursuing more reasonable approaches to PFAS. State court decisions on issues such as the collection of utility fees and wet weather management are likewise having increasing implications for our members and threaten to expand to broader regional or even national stages.

While these actions unfold, many state-based utility groups may be unwilling or unable to respond effectively. NACWA, meanwhile, does not have the resources to be a primary actor in 50 states. Building on the previous session, panelists will provide some perspective from their states and lead a discussion on how NACWA should 'pick its battles' and, perhaps more importantly, how the Association can collaborate with and create a sense of urgency for state groups to 'step into the breach' as advocates on behalf of our shared priorities and where and how it can best work with the more well-resourced and active state groups.

The Role of Technology & Technology Providers in Advancing Clean Water Success
