Tax-Exempt Municipal Bonds Sustain Missouri's Water Infrastructure

\$485 million – The value of tax-exempt municipal bonds communities across Missouri issued in 2016 to fund improvements to drinking water and wastewater infrastructure.

\$206 million – Additional debt service costs cities and towns in Missouri would incur over their payback periods if interest earned on these bonds was fully taxable, a 25 percent increase.*

\$53.8 million – Clean Water and Drinking Water State Revolving Fund assistance the federal government provided to Missouri in 2016. Fully taxing municipal bond interest would cost the state nearly 4 times the value of this year's SRF assistance.

Affordable investment in Missouri's water infrastructure should not be a consequence of tax reform.
