Tax-Exempt Municipal Bonds Sustain Washington's Water Infrastructure

\$1.17 billion – The value of tax-exempt municipal bonds communities across Washington issued in 2016 to fund improvements to drinking water and wastewater infrastructure.

\$498.3 million – Additional debt service costs cities and towns in Washington would incur over their payback periods if interest earned on these bonds was fully taxable, a 25 percent increase.*

\$41.8 million – Clean Water and Drinking Water State Revolving Fund assistance the federal government provided to Washington in 2016. Fully taxing municipal bond interest would cost the state nearly 12 times the value of this year's SRF assistance.

Affordable investment in Washington's water infrastructure should not be a consequence of tax reform.
